WAIVER AND RELEASE

I, the afore-mentioned person, wish to be self-excluded from the Sun International Gambling Operation(s) specified above. I confirm that this application is made voluntarily on my own free will and without any undue influence. I am of sober senses and not under the influence of any substance that could hinder me from making a rational and informed decision regarding this application. In addition, I confirm that I am capable of making this decision without the assistance of any other person.

By filing this application, I understand that I am a problem gambler and that I am assuming the sole responsibility of refraining from accessing the respective designated gambling area(s) and/or participating in any gambling activities and/or promotional competitions offered by Sun International's Gambling Operation(s). Furthermore, I give up any entitlement to entries made or prizes won in respect of such promotional competitions. A re-draw will occur for prizes won at promotional competitions without any compensation to me.

I am further understand and accept that the specified Gambling Operation(s) will take reasonable and practical steps to prevent me from accessing its designated gambling areas and prevent me from accessing SunBet, and from participating in its gambling activities and relevant promotional competitions. Also, I accept that my self-exclusion will be implemented within a reasonable period, after which I will be notified. If no notification is received, I assume the responsibility to make the necessary enquiries regarding the implementation of my self-exclusion request.

Furthermore, I understand that if I am discovered within the designated area(s) concerned that I may be ejected by the casino and will be denied the opportunity to place a bet with SunBet (as the case may be). I acknowledge that the afore-going conduct constitutes trespassing in respect of a casino and that the respective casino(s) may have me arrested for trespassing where after I will be criminally prosecuted. I authorize the specified Gambling Operation(s), its employees and agents to refuse me entry to its designated gambling area(s) or deny me access to SunBet. I know and understand that by being denied access to the participate in gambling in any province, I will

automatically be excluded from participation in gambling activities in the North West province in terms of the gambling laws of the North West Province.

Also, I accept that I will not be entitled to place a wager or bet on gambling games, contingencies or devices offered at the relevant Gambling Operation(s). Accordingly, I will not be entitled to any winnings accruing to me as a result of such wagers or bets placed. Such winnings shall be forfeited and thereafter donated to the charities and/or good causes supported by the Gambling Operation(s) or the Sun International group. I acknowledge that I am also not entitled to a claim for losses or damages of any nature that may have been incurred from losing bets or wagers.

By signing this release and acknowledging the contents thereof, I forever release, remise, and forever discharge the specified Gambling Operation(s), its employees and agents, and where applicable, gambling regulators from any and all manner of actions, causes of action, suits, debts, judgments, executions, claims and demands whatsoever, known or unknown, in law or equity, which I, the undersigned, and my heirs, successors, administrators, executors, and assigns ever had, now has, may have, or claim to have against any or all of the afore-said persons and entities arising out of or by reason of the processing, enforcing or other action or omission relating to this application, including but not limited to their negligence in implementing this application or releasing its contents to any party as may be required for the implementation of this application.

I also give expressed and informed consent to the processing and further processing of my protected personal information contemplated in the Protection of Personal Information Act, 2013 to the full extent permissible by law. Furthermore, I give expressed and informed consent for the specified Gambling Operation(s) to retain my protected information for historical, research and statistical purposes, and to further its legitimate business interest for periods exceeding any prescribed periods to the full extent permissible by law.

I acknowledge that the specified Gambling Operation(s) encourages me to utilize the free counselling and treatment services available through the National Responsible Gambling Programme ("NRGP"). I understand that responsible gambling counselling or treatment by a psychologist or psychiatrist registered with the National Health Professions Council of South Africa or NRGP counsellor and proof of such counselling is a pre-requisite to apply for upliftment of this self-exclusion. I accept that the NRGP, its employees or agents may contact me from time to time for research purposes.

I accept that the specified Gambling Operation(s) will take reasonable steps to remove my name from its mailing lists. In this regard, I undertake to notify the Gambling Operation(s) concerned should I receive any errant communication or offers relating to gambling. I accept that due to the timing of the implementation of this application, I may, for a period after the implementation, receive such communication and offers that may have been processed at an earlier stage.

I take cognizance of the fact that this application is legally binding on me. Furthermore, I understand that the clauses in this application are severable from each other. To the extent that any clause herein be found unenforceable in law, then that clause or part thereof will be severed from this application and the remaining clauses and parts shall remain in force.
